Who we are

We are a multi-disciplined workplace service provider whose operations include but are not limited to clinical waste services, washroom facilities, water coolers, water boilers, dust control mats, cleaning & hygiene supplies, deep cleans and specialised dosing systems.

What we need

Trust Hygiene Services Limited will be what is known as the "Data Controller" of the personal data you, the client provide to us. Trust Hygiene Services Limited company registration number is 04443970 and it's registered address is Principle House, Leamore lane, Bloxwich, Walsall, West Midlands, WS2 7PS.

We will only collect basic personal data about you where processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract. This may include special categories of personal information about you (often known as 'sensitive personal data'). This information does however include for example, details necessary to do business together either now or in the future such as your name, address, email address, mobile, company details, job title.

Why we need it

We need to know basic personal data in order to offer or provide you with services at your business whether that be now or in the future. We assert our right to be recompensed in return for these services, as per the service agreement or contract we have, or may have in the future with you. If you do not provide this information then we will be unable to provide the services you have requested

What we do with it

All the personal data we hold about you will be processed by our staff in the United Kingdom and no third parties will have access to your personal data unless there is a legal obligation for us to provide them with this, for example, governing bodies such as the Environment Agency. Please be aware, however, that your information may be stored on a cloud-based system whose servers are located within the European Union. We will take all reasonable steps to ensure that your personal data is processed securely. We will not sell or rent your information to third parties. Email addresses are transmitted normally over the Internet and this can never be guaranteed to be 100% secure. While we strive to protect your personal information you transmit to us, you do so at your own risk and we make our best effort to ensure its security on our systems.

How long we keep it

We will generally keep your personal data for a minimum of 3 years, or for the length of the contract we have with you, after which time it will be destroyed if it is no longer required for the lawful purpose(s) for which it was obtained. We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information to

fulfil our statutory obligations. More information on our retention schedule can be found in our privacy policy. For example, we are bound by legislation to keep records relating to waste transfer/duty of care and service recognition for a minimum of 3 years.
