### **TERMS OF USE**

#### **BACKGROUND:**

These Terms of Use, together with any and all other documents referred to herein, set out the terms of use under which you may use this website, <a href="www.trusthygiene.co.uk">www.trusthygiene.co.uk</a> ("Our Site"). Please read these Terms of Use carefully and ensure that you understand them. Your agreement to comply with and be bound by these Terms of Use is deemed to occur upon your first use of Our Site and you will be required to read and accept these Terms of Use when signing up for an Account. ### 2. Information About Us

- We are regulated by the Certificate of Registration under the Waste (England and Wales) Regulations 2011 and the Environment Agency. Our Registration Number is CBDU143881.
- 2.3 We are a member of The SDMSA (Sanitary Medical Disposal Services Association)

### 3. Access to Our Site

- 3.1 Access to Our Site is free of charge.
